



## Internet Safety—Don't Lose Your Money or Your Identity

You hear about it every day. Someone's identity has been stolen, or an individual has lost money through an internet scam. The internet has revolutionized how we bank, shop and communicate. Unfortunately, there are many internet users who will take advantage of unsuspecting consumers. By following a few simple guidelines, you can significantly reduce your risk.

- Pay for your internet purchases using a reputable on-line payment service such as PayPal. If possible, use a separate credit card with a low credit limit for internet purchases. Doing so reduces your exposure if account information is stolen.
- If it sounds too good to be true, it is. From hot stock tips to a deposed Nigerian Prince looking for an account in which to transfer his millions, there is always some sort of scam waiting for the unwary consumer. Do not buy it.
- Reputable companies will never ask you for your password or account information in an Email. You may receive correspondence that purports to be from your bank or credit card company saying that you must login and renew your information or your account will be suspended. *Such messages can look very official and intimidating.* They may even have the logo, address and phone number of the financial institution. Clicking on a link in these Emails will almost always direct you to the culprit's website set up for the exclusive purpose of *stealing your personal information.*
- Do not save passwords on your computer. Keep a written list of passwords in a secure location and change them frequently. When your computer is online, unscrupulous people with basic computer skills can harvest such information from your hard drive and you will never know about it until *creditors come knocking at your door demanding payment for purchases that you never made.*
- Most data that is stolen on-line comes through security vulnerabilities in the user's computer. Programmers have learned to exploit flaws in software to their advantage. In my 25 years of computer experience, this is where I see most computer users fall short. Keeping your computer current with the appropriate security and anti-virus updates is essential to keep the bad guys out.
- Remember that on-line predators abound and unsupervised children or teens can be particularly vulnerable. Talk to children about the importance of not sharing private information, especially in chat rooms or social sites such as MySpace. Predators can find your child if they know the school and have a photo. Keep a minor's computer where you can monitor usage, and watch your child's computer activities frequently. Also, if you are not computer savvy, there are a multitude of softwares designed to assist you in restricting access to questionable sites and monitoring internet activity. 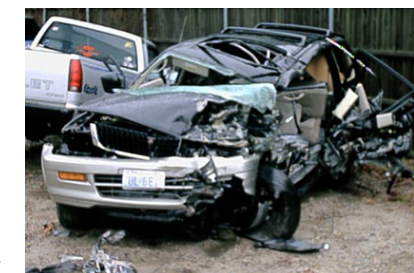


## What to do When a Crash Happens

Fortunately, many people will live an entire lifetime without becoming involved in a motor vehicle crash. Most car insurance usually does one of three things. The insurance may pay you or a family member if you have a claim. It may pay someone else who has a claim that the insurance covers. Or it may pay for an attorney to defend you if a claim is made against you.

Other than yourself, when you buy an insurance policy, you buy protection for a number of other people who are close to you. Protected people include your family members (even if they are struck as a pedestrian or injured in someone else's vehicle), your passengers, and any person whom you allow to drive your car. In addition, purchased insurance usually applies to the vehicle that you insure, no matter who is driving it. Most insurance policies also protect you and insured family members regardless of whether or not you own the car involved in the accident.

When injuries are serious or property damage is severe, you may need representation by an attorney. A reputable attorney who primarily practices in the field of vehicle and insurance litigation can explain the issues that you will face so that you can make an accurate assessment as to whether or not legal counsel will be needed to collect applicable insurance.
