NOTICE OF HEARING ON MOTIONS TO REFER
TO THE MASS LITIGATION PANEL

WHEREAS, pursuant to Rule 26.06 of the West Virginia Trial Court Rules, Chief Justice Robin Jean Davis, of the Supreme Court of Appeals of West Virginia, received motions to refer the above-styled proceedings and additional Marcellus Shale cases referenced in Exhibit A to "Plaintiffs' Supplemental Brief in Support of Plaintiffs' Expedited Motion to Refer Cases to Mass Litigation Panel" filed in James C. Shreves and

Eva L. Shreves vs. Antero Resources, et al., Ritchie County Case No. 14-C-20. (See Exhibit A attached).

WHEREAS, by Administrative Order entered on July 30, 2014, Chief Justice Davis ordered the Mass Litigation Panel or a designated member thereof to conduct a hearing to receive evidence and entertain arguments by the parties or any judge relative to the issue of whether these cases should be referred to the Mass Litigation Panel, and to submit findings of fact and a recommendation to the Chief Justice, including a specific list of the cases affected by the recommendation.


NOW THEREFORE, the Mass Litigation Panel ORDERS that a hearing be conducted at 9:00 a.m. on September 9, 2014, in Courtroom Four, also known as the Ceremonial Courtroom, on the Second Floor of the Kanawha County Courthouse, at 409 Virginia Street, East, in Charleston, West Virginia. The purpose of the hearing will be to receive evidence and to entertain arguments by the parties or any judge relative to the issue of whether these cases should be referred to the Mass Litigation Panel, and to submit findings of fact and a recommendation to the Chief Justice, including a specific list of the cases affected by the recommendation. The Honorable Alan D. Moats, The Honorable John A. Hutchison, and the Honorable Derek C. Swope will preside.

Plaintiffs' counsel is ORDERED to prepare a comprehensive list of Marcellus Shale cases to be considered by the Mass Litigation Panel in its recommendation to the Chief Justice. Plaintiffs' counsel shall file the case list in the *Andrews, Stutler* and *Shreves* cases and serve the case list on The Honorable Alan D. Moats, The Honorable John A. Hutchison, the Honorable Derek C. Swope, Mass Litigation Manager Kimberley R. Fields and all counsel of record by no later than September 2, 2014.



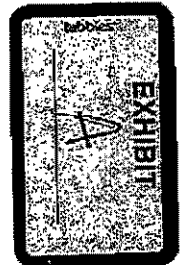
